Consent Agenda: The Board reviewed the regular meeting minutes from August 2024. The financial

Manager's Updates: John Fitzgerald - August BOD removal was 92%. Ammonia is still high @ 11.1mg/L. TIN results were just above our two year rolling average limit of 10, at 12mg/L. Our 2 year rolling average is currently 7.7mg/L. The WW plant experienced several power interrupts during August. It affected flow and possibly our sampling results. Tim's Water Plant had the same issues last month. He said YVEA told him they had issues.

New Business:

Old Business: Zirkel Wireless Contract – Mrs. Fisher would like to make sure there is protective language in the contract, before signing the contract, that will protect the District from any liability if Zirkel should cause any damage with their antennae and what it radiates to the general population. Mr. Lomas will try to set up a meeting with Mr. Belvo at Zirkel to get these answers before signing.

Lot 1 Easement – Mrs. Sherman, the attorney on this project, has let Ms. Lightfoot know that it should be finalized this week.

Tap Fees- Tabled until new law firm is hired

Reserve Investments - Bank of America does not seem to be an option any longer. Mr.

Ioffredo is going to meet with Yampa Valley Bank at the end of this week to see if that would be an option.

Legal Team – The Board would like to go forward bringing on the Lyons Gaddis Law Firm from Denver. Mr. Lomas will reach out to hire them and task them with review of the Rules and Regulations. We would like to have recommendations for how to update and specifically how to fairly charge commercial short term rental locations.
